## **PROSPECTUS**

**AWARDS:** Over \$5,000.00 in cash and prizes will be awarded including a "Best of Show", "Best Oil Painting", "Best Pastel Painting", "Best Nocturne", and "Best Quick Draw" award. Awards will be determined by the Judge of Awards.

JURORS: Jurors of Selection are Colorado oil painter Joshua Been (<a href="www.joshuabeen.com">www.joshuabeen.com</a>), Texas pastel painter Linda Dellandre (<a href="www.lindadellandre.com">www.lindadellandre.com</a>), and Santa Fe gallery owner Mike McKoskey (<a href="www.linArtSantaFe.com">www.linArtSantaFe.com</a>). The Judge of Awards is California oil painter Teresa Onoda (<a href="www.onodaart.com">www.onodaart.com</a>). Teresa Onoda will also offer a workshop June 14th and 15th in Santa Fe (separate registration and fee). The Judge of Awards for the Quick Draw Competition and for "Best Nocturne" is New Mexico oil painter Damien Gonzales (<a href="http://damiengonzales.fineartstudioonline.com">http://damiengonzales.fineartstudioonline.com</a>).

A total of 49 artists will be selected by the jury to participate in the event. Each juror will score each submission on a 1-7 scale. The selection criteria will be the highest total by artist of the 3 scores on his or her 3 submissions.

**ELIGIBILITY**: Open to all artists worldwide working in two dimensional media excluding photography and digital art.

- Artists must submit images of 3 original works for Entry Jury consideration.
- All work must be at least 80% completed en plein air within the past two years.
- All work must be original.
- Work done under the guidance of an instructor is not eligible.

## **ENTRY & PARTICIPATION FEES:**

The entry fee is \$45.00 (non-refundable). Entry fee may be paid online or by check mailed to PAPNM Treasurer, 130 Cougar Road, Carlsbad, NM 88220 to be received no later than <u>April 7</u>, <u>2014</u>. Jury results notification will be by email.

Artists accepted into the event agree to become members of PAPNM (annual membership fee is \$30.00), register for the event, and pay a participation fee of \$75.00 (non-refundable) within 10 calendar days of notification of acceptance.

## \*\* PAINT-OUT LOCATIONS

- Artists are free to paint on their own anywhere within the designated "2014 PASF Paint-Out Zone" (see attachment), subject to any/all restrictions posed by private property owners and public agencies.
- Each day from June 8, 2014 through June 12, 2014, there will be one optional scheduled paint-out at a scenic area in the Santa Fe region. Artists are welcome, but not required, to participate in these scheduled paint-outs.

### \*\*\* SUBMISSIONS FOR EXHIBITION

- A <u>maximum</u> of 2 works created by each artist en plein air during the event may be accepted for inclusion in the exhibition.
- All work must be for sale. Artists will receive 50% of the sales price of the work.
- Each dimension (length and width) of any image <u>including the frame</u> shall not exceed 24". Images that exceed the maximum outside framed dimension of 24" in either length or width will not be hung.

- Accepted work must be sturdily framed and ready to hang with D-rings and wire.
- No sawtooth hangers will be accepted.

You will be given the contact information for clients who purchase your work. All accounts will be settled within thirty (30) days of the conclusion of the exhibition. Prices of art are not subject to change once registration is submitted. You will receive proper attribution in the gallery based on information provided by you in this application.

#### **INSURANCE:**

All possible care will be taken of the work submitted to the exhibition. The gallery will not assume responsibility for work improperly framed or poorly packaged for shipping. Work will be insured at InArt Gallery but not in transit.

#### **RETURN OF WORK:**


You are responsible for picking up or arranging shipping for any work not sold by the end of the show period.
