

2024 Los Alamos Non-Juried Paint Out and Show Prospectus

This is a non-juried plein air event open to members of Plein Air Painters of New Mexico held in Los Alamos, NM. PAPNM is a 501(c)(6) non-profit organization of artists dedicated to preserving and promoting painting "en plein air" - painting in the open air or outdoors.

Eligibility

Open to PAPNM members working in two-dimensional media, excluding photography and digital media.

ENTRY FEES, DEADLINES, AND EVENT DATES

- Registration opens May 30, 2024 at papnm.org.
- \$39 registration fee.
- Event painting period July 26 at 3 PM through July 31st, 2024 at art turn-in (no later than 4 PM)
- Drop off work July 31, 2024 from 1 4 PM at Fuller Lodge Art Center Gallery (FLAC).
- An opening reception is scheduled for August 2, 2024 from 5 7 PM at FLAC.
- The show will be on display at FLAC from August 2 August 30, 2024.
- Pick up work 10 AM 1 PM August 31, 2024.

ELIGIBILITY

- All applicants must register online at papnm.org
- The first 35 PAPNM Members who apply to the 2024 Los Alamos Paint Out and Show will be accepted into the show.
- Due to PAPNM's 501(c)6 status, only PAPNM members are allowed to participate and exhibit.
 PAPNM Membership must be current with dues paid in full before submitting to the call for entry for the exhibition. To join, visit www.papnm.org, and click "Join Us" in the top menu.
 Follow the instructions for member application or renewal and payment.
- While PAPNM signature and master signature members are welcome to participate, they will
 not be eligible for awards.
- This call is for all current PAPNM members working in two-dimensional media, excluding photography and digital media.

PARTICIPATION FEES AND REQUIREMENTS

- Application Fee \$39 payable to PAPNM upon entry
- Only PAPNM members may apply for this event. Annual membership fee is \$40.00 per calendar year. Join us at https://papnm.wildapricot.org/Join-Us
- Have your work at the Gallery and available for sale for the duration of the event at the stated commission.
- Participating artists shall allow PAPNM to collect 50% commission on their behalf, from Fuller Lodge Art Center* Gallery, to be paid to PAPNM by September 15, 2024. PAPNM will pay artists their commission by October 1, 2024.
- Artists release Fuller Lodge Art Center* Gallery from responsibility for any damage to artwork before, during, or after the show.
- Upon the opening of the show, it is the artist's responsibility to check the Fuller Lodge Art Center* and the PAPNM websites to confirm the accuracy of all information regarding their artwork including price, dimensions, spelling, title, and artist's name.
- Fuller Lodge Art Center* and PAPNM have permission to use all photos and information relating to the submitted artwork for promotional purposes regarding the event.
- By participating in this show, artists agree that PAPNM may release contact information of participants to potential advertisers.
- If the artist has a customer for their painting created during the event, they should refer the customer to Fuller Lodge Art Center* Gallery to sell the piece on their behalf.

EXHIBITION

Location: Fuller Lodge Art Center* is located at 2132 Central Ave., Los Alamos, NM 87544

2024 Los Alamos Paint Out and Show is a cooperative effort between PAPNM and Fuller Lodge Art Center.

PAINTING AND HANGING REQUIREMENTS

- Each PAPNM artist will be allowed to enter two paintings that were stamped and completed during this event's paint out along with one "Tiny Treasure" painting (surface provided upon check-in.)
- No minimum size.
- Maximum size per piece is 20" x 24" or 480 square inches unframed.
- All work must be at least 80% completed en plein air, during the paint out period.
- Submitted paintings must be stamped and painted inside the designated paint out area.
- Have your work at the Gallery and available for sale for the duration of the event at the stated commission.
- Each artist must complete and turn in a FLAC inventory sheet for each submitted artwork.
- All work must be sturdily framed, or gallery wrapped and ready to hang with D-rings and wire.
 No saw tooth hangers will be accepted. Artists will not be allowed to substitute other work not from the event for improperly framed work.
- The artist will need to photograph their work and email the images to <u>lapaintout2024@gmail.com</u> by midnight on Wednesday, July 31. The images should be high

- quality jpegs, a minimum of 5" x 7" 300dpi. Ideal file size is 1MB 3MB. It is recommended you photograph the work before it is framed for clarity.
- Images may be posted on the Fuller Lodge Art Center* website (fullerlodgeartcenter.com) and may be used for additional publicity. PAPNM may also post images on their website.
- Fuller Lodge Art Center* must receive a FLAC inventory sheet for each submitted artwork.

PAINT OUTS

- Paint Out locations and map will be shared in the welcome letter and at check-in/registration.
- Check-in and stamping will occur the evening of July 26, 3-5:00 pm and July 27, 8 10 AM.
 Stamping will also be available during other times, information will be provided at artist check-in
- Paint out will be held daily beginning 3 PM on July 26 through July 31st at turn-in. Art must be turned in no later than 4 PM on July 31.

COMMISSION

All work must be for sale. Artists will receive 50% of the sales price of the work. Fuller Lodge Art Center* Gallery will receive 40% and PAPNM will receive 10%. Fuller Lodge Art Center* Gallery will handle sales tax. Payment to artists by PAPNM will occur by October 1, 2024.

WORKSHOP (separate registration and fee)

Peggy Immel will teach a workshop on July 26 from 9 AM – 3 PM. There is an additional fee of \$100 for the workshop, 12 students maximum.

- PAPNM has the right to refuse or disqualify any work that fails to meet eligibility, entry, and exhibition requirements
- Neither Fuller Lodge Art Center* nor PAPNM, their agents, employees, volunteers, or anyone
 working on the exhibition will be held responsible for any loss or damage to artwork and
 insurance is the responsibility of the artist.
- PAPNM and Fuller Lodge Art Center* reserves the right to reproduce accepted artwork for

publicity purposes.

- PAPNM reserves the right to reject work deemed unsuitable for public viewing.
- All payments are final and non-refundable.
- Your entry and payment constitute acceptance of all conditions and terms of this prospectus.
