Step Up Gallery at Mesa Public Library in Los Alamos, NM invites you to submit <u>up-to-four</u> small, framed paintings to their 2023 Holiday "Gift of Small Paintings" exhibit. One focus of this exhibit is to provide a sales opportunity for New Mexico artists to show and offer their small, framed art as possible holiday gifts. Artwork photos and information will appear online in Step Up Gallery Art Market where purchase with any bank card is possible in addition to an exhibition in Step Up Gallery, top level of Mesa Public Library, in historic downtown Los Alamos. There is no charge to submit up-to-4 small works. Please <u>carefully read</u> the following rules for submission and deadlines:

- 1. Any <u>original artwork</u> (2-D) in any media can be submitted except photography or digital art, for example: oil, watercolor, pastels, ink, gouache, drawing media, numbered prints, fiber or mixed media (substrate should be archival). Please ONLY submit art that has not yet shown at Step Up Gallery.
- 2. Maximum size of artwork including frame is **480** square inches. Example: a 12" x 18" or a 14" x 17" painting in a 3"- wide-frame fits within this limit. There can be no exceptions to the maximum limit. There is NO minimum size limit. Frames are not required for finished edge, stretched canvas, fiber or some other mixed media art but must have a way to easily hang on wall.
- 3. Each artwork MUST be priced between \$75 \$475, a range appropriate to garner purchasing interest as a holiday gift.
- 4. For ease of reliable hanging, please submit only work with a wire on the back that can be hung on a hook. Frame must be sturdy and in salable condition.
- DELIVER ARTWORK to Step Up Gallery, top level of Mesa Public Library, 2400 Central Ave., Los Alamos, NM 87544 on either Friday, Nov. 17 between noon – 5pm OR Saturday, Nov. 18 between 10am and 2pm. Please tape a tag on the back of each piece with artist's name, phone number and title of the art. Please clean the frames and/or glass. Storage not available for wrappings.
- 6. HOW TO APPLY: Go to <u>https://stepupgallery.org/cfa-download/</u> to download a fillable PDF as your application. The information necessary to show and sell your artwork needs to be submitted in a way that allows speedy and accurate transmission to your wall tags and online sales market. You must use a computer or smart phone to accurately type in your information in the correct lines. We will not question or correct any mistakes made on your application. Once the PDF is correctly filled-in, please save it as your last name and 1st initial, then email to: <u>stepupgallery@icloud.com</u> with jpeg photos by the deadline of midnight on Thursday, November 16, 2023.
- 7. With your application, submit high resolution jpegs (220-300 ppi) with the shortest side no smaller than 1200 pixels (4"). Please rename the jpeg files with your LAST NAME and TITLE of artwork. Please submit well-lit, straight on photos of your art that are infocus and do not have glass reflections. These will be used to sell your art online so it's in your best interest to provide good photos that closely resemble the colors in your original art. Your application may be rejected over very poor-quality jpegs.
- 8. Since this exhibit is not pre-juried, the management of Step Up Gallery reserves the right to reject a submission without explanation.
- 9. By submitting artwork to this show, you, as the artist, automatically give a Release of Liability to Step Up Gallery, Mesa Public Library, Los Alamos Arts Council, Los Alamos County and any of its employees or contractors for your losses due to theft or damage to your art while on Mesa Public Library premises. You also concede that any of the above entities may use images of your art in Step Up Gallery's marketing, advertising or promotion.
- 10. Step Up Gallery retains 35% commission on any sale of submitted artwork purchased during the exhibit. Step Up Gallery will collect and pay appropriate sales tax.
- 11. The remaining 65% of your sales will be mailed to you in a check within 30 days after close of exhibit.
- 12. Unsold work must be Picked-Up at Step Up Gallery on Thursday, Jan. 4 between noon and 5pm OR Friday, Jan 5, between 1-5pm.
- 13. The first **100** emailed submissions will be accepted on a first-come-first-served-basis. By submitting the application, you as the artist, are committing to delivering the artwork pictured and described in your application on the delivery times noted above.
